The Exceptional Family Member Program

-Army Community Service (EFMP-ACS) assists Service Members and their Families who have Family Members enrolled in EFMP through a medical screening. EFMP-ACS provides services, links Families to community resources, coordinates special events and activities, and advocates for Families.

Housing Support

- Assist with requests for special modifications or special accommodations
- Connect to community resources for ADA issues

Multidisciplinary Inclusion Action Team (MIAT)

- May be required for enrollment in Child and Youth Services activities
- Considers child's health & safety
- Determines required accommodations
- Creates & implements a plan

Educational Support

- Support with Individualized Education Programs (IEPs)
- Information for tutoring or other educational services







Support Groups & Training Workshops

- Support groups to share information
- Workshops on behavior management, IEPs, Guardianship Transfer of Rights, and other topics
- Information from local community organizations

Recreational Activities

- Organized with special needs in mind
- A variety of activities offered
- Small groups
- Referrals to community activities & organizations

Respite Care

For qualifying Families, Respite Care provides temporary relief for the primary caregiver of an Exceptional Family Member with a severe or chronic condition.

Systems Navigation

Assistance with military and community processes, connection to resources, and advocacy with IEPs and other settings.

Multidisciplinary Inclusion Action Team (MIAT)

WHAT IS MIAT?

The **Multidisciplinary Inclusion Action Team** (MIAT) is a regulatory process to assess requirements that support children/youth with special needs requesting child care/ youth supervision options in Army Child & Youth Services (CYS).

The MIAT team include parents or guardians; ACS Exceptional Family Member Program (EFMP); Army Public Health Nurse (APHN); Child & Youth Services (CYS) designee; and other appropriate medical personnel that work together to address placement of children.

What is the Parent's Role?

Parent participation is crucial. You will be informed of the date, time and location of the **MIAT**. In order to assist with this placement process you may be asked to provide information that may include: medical documentations, statements of illnesses, allergies, reactions and treatment, copies of the Individualized Family Services Plan (IFSP), Individualized Education Plan (IEP), and Behavioral Support Plans (BSP). All of these items may be needed to facilitate the **MIAT** process.



MIAT Procedures

Parent will complete a CYS Health/ Development Screening, DA Form 7725. If the parent checks "yes" on the Health Screening/ Development Screening Form, a Medical Action Plan (MAP) and/or Special Diet Statement will be provided to the parent (as needed). The MAP/Special Diet Statement would need to be filled out and completed by a physician before returning the forms to Parent Central Services.

Parent Central Services will then forward the Health/Developmental Screening Form and completed MAP/Special Diet Statement or any Health Screening Forms with medications listed, or any other medical conditions or therapies disclosed by the individual completing the Health/Developmental Screening Form to APHN and EFMP for review and recommendations.

In the meeting, the **MIAT** team will discuss recommendations for creating an developmentally appropriate environment; taking into consideration any health, developmental, physical, social, emotional, learning, and behavioral issues that affect your child. This will help determine how CYS can best meet his or her needs.

Respite Care

The Purpose of Respite Care

The Army recognizes that caring for a Family Member with severe special needs can be emotionally and physically challenging, especially with a unique military lifestyle. Through the Exceptional Family Member Program (EFMP), respite care is provided to eligible Families, for twenty-five hours a month, to allow the primary caregiver relief to address personal needs or the needs of other Family Members. Respite Care allows the primary caregiver time to rest and reenergize so that he or she can return to caring for their loved one.





How to Apply

Respite Care Eligibility:

- The Family Member with special needs must be registered in the Exceptional Family Member Program (EFMP).
- Must reside with the Service Member (SM), with the exception of when the SM is on an unaccompanied tour/ geographically separated (copy of PCS orders are required).
- Must have a qualifying medical condition.
- Must not be receiving Tricare ECHO respite care, state, or private insurance respite care support.

Initial required documents (available at Army Community Service (ACS) Exceptional Family Member Program office) include:

- A completed, stamped, and signed DA Form 4700 — Medical Record-Supplemental Medical Data — by the physician who has medical knowledge of the Exceptional Family Member (EFM) with special needs.
- A completed DA Form 5189 Application for Respite Care for Children and Adults.
- A completed and signed DD Form 2870 —Authorization for Disclosure of Medical or Dental Information

Once completed, all three forms must be submitted to the ACS EFMP office. The forms will be reviewed by a medical physician to ensure medical criteria is met as established by Army Medical Command (MEDCOM) and provide recommendations as to level of care.

Respite Care (Continued)

The Family will be asked to complete a personal interview with the ACS EFMP staff and complete additional documents.

The Review Process

The completed respite care application package will be reviewed by a respite care panel consisting of the EFMP Manager, the ACS Chief or appointee, an independent medical physician, and an Army Family Life Chaplain. The panel will provide recommendations as to level of care.

With the recommendations from the respite care panel, the Garrison Commander will have final approving authority on all respite care applications. Families will be notified telephonically and by postal mail as to the status of their application.

The entire process can take an average of **90 days** to complete. Once approved, respite care eligibility will be effective for one year. Families will be responsible for reapplying annually or their care will automatically be discontinued.

Eligible Level III and Level IV EFMs will receive a flat twenty-five hours, monthly.

Care Providers

ACS EFMP provides administrative support to the respite care program. Respite care providers are contracted through Strategic Resources, Inc., (SRI).

Levels of Care Provided

Depending upon the eligible EFMs needs, there are two levels of respite care provided.

Level III – Significant medical conditions that require coordination of care by health care providers, ancillary services, or others in order to sustain a reasonable level of health. Conditions at this level of care include but are not limited to: recurrent and unstable seizure activity that requires close monitoring for safety; uncontrolled, unstable insulin dependent diabetes in an individual, regardless of age, or newly diagnosed insulin dependent diabetes in a child under five years of age; significant advanced multiple sclerosis with ambulation and safety needs, and those who need special assistance with food intake.

Level IV – Conditions at this level of care include but are not limited to: severe continuous seizure activity, tube feeding via a feeding pump, suctioning of tracheotomy with suction equipment, monitoring of home apnea monitor and home ventilator, and conditions which require extensive Family involvement in care giving.

Respite Care Levels III and IV contemplate a level of training and care giving that goes beyond conditions that only require constant supervision based on uncontrolled behavior with safety issues including EFMs prone to elopement or inability to comprehend dangerous actions. Autism (even severe autism) do not rise to a Respite Care Level III or IV. There must be other significant medical conditions as stated above.

The Purpose of the Army Community Service (ACS) Exceptional Family Member Program (EFMP) Mobi-Chair:

ACS EFMP recognizes that caring for a Family Member with mobility impairments can be emotionally and physically challenging. We recognize it maybe difficult to gain access to enjoy outdoor recreational activities in Hawaii. The Mobi-Chair may assist in making outdoor activities more accessible to those with mobility impairments. Military ID Card holders may borrow the Mobi-Chair FREE of charge.

Required Documents:

Valid Military ID

Loan Period:

The Mobi-Chair is loaned for a 7 day period. There are two chairs in rotation. The Mobi-Chair is a high quality, amphibious rolling beach chair that provides a seamless transition from sidewalk to beach to water. The Mobi-Chair was designed for wheelchair users and people with special needs.

Transportation:

Transportation and storage is convenient. The Mobi-Chair is quickly assembled or disassembled by operating the quick release pins and joints without tools. It can easily fit into a vehicle.

Sensory Lending Closet



ACS EFMP recognizes that caring for a Family Member with special needs can be emotionally and physically challenging, especially while transitioning to and from a new duty station. During the transitional period of the move, the impact of prolonged temporary hotel lodging can lead to increased stress and possible regression for some children. The Sensory Lending Closet is designed to mitigate some of these challenges by loaning sensory items typically used by parents to assist in comforting children with special needs. Families who have a Family Member enrolled in EFMP may borrow the items FREE of charge of a thirty day period in the absence of their household goods.

Required Documents: Valid Military ID, copy of orders and enrollment in EFMP.

Loan Period: Items are loaned for a thirty-day period; however, extended borrowing may sometimes be accommodated, if inventory permits. The ACS EFMP Sensory Lending Closet is available to all incoming and outgoing Families who have a Family Member enrolled in EFMP.

- Sensory Gel Maze
- Core Disk
- Pressure Foam Roller
- Find It Game
- Press & Stay Sensory Blocks
- Magnetic Building Block Tiles
- Sensory OT Brush
- Calming Bottle
- Peanut Ball with hand pump
- Weighted Seek & Find
- Small Marble Panel with Base Optional items:
- Weighted Blanket
- Sensory Bed Sheet

Inventory may fluctuate based on demand.

EFMP Rights & Responsibilities

Report Changes in EFMP Status. The EFMP enrollee will immediately notify the EFMP Coordinator, Medical Treatment Facility, and/or school on any changes that affect the status of the EFM.

Re-enroll (if applicable). Enrollment update is mandatory every three years.

Contact the Installation EFMP Coordinator upon arrival. Initial contact must be made with the Installation EFMP Coordinator at ACS to assist in identifying resources and services available to EFMP enrollees at the installation.

Notify Installation EFMP Coordinator upon DEROS. EFMP enrollees will immediately notify the Installation EFMP Coordinator at ACS once they receive orders transferring them to a new installation or any other location. This allows for the opportunity to coordinate resources and services available at the gaining installation or location.

Privacy and Confidentiality. Each EFMP enrollee is afforded reasonable privacy in regard to the services they receive, the Family Member's special need, and the extend of the Family Member's disability. The EFMP enrollee records are kept confidential.

Medical Treatment. EFMP enrollees will be allowed access to medical care from the Medical Treatment Facility or referred to the appropriate medical Facility for service in accordance with the Family Member's special need.

Educational Services. Department of Defense Dependent Schools (DoDDS) if applicable, will make reasonable accommodations for school age children identified as EFM. Those services may include but are not limited to school and classroom modification, Individual Educational Plans (IEP), special education services, and/or individual teaching methodologies. These services will coincide with the Public Law 105-17, Individual with Disabilities Educational Act (IDEA).

Housing. EFMP enrollees will have access to reasonable accommodations to their Family housing in support of the Exceptional Family Member. Those accommodations shall be in the form of renovations, access to the building and parking and anything else associated with quality of life for the EFMP enrollee. Off post requirements are looked at on a case-by-case basis due to the nature of contracts and leases with local laws, regulations and landlords.

Public Facilities. In accordance with PL 101-336, American with Disabilities Act of 1990, facilities that receive government funding will provide reasonable accommodations to individuals identified with disabilities.

Information. EFMP enrollees will be kept informed on issues that affect them and their status as EFMP enrollees.

Transfer and Continuity of Services. EFMP enrollees shall be afforded the opportunity to transfer and continue services upon their transition to any US military installation or other location to include all the services



Out Processing Information

When it is time to leave Hawaii, please remember to do the following to help with your Family's transition to your new duty station:

- \Rightarrow Bring copies of Child & Youth Services (CYS) documentation for each child.
- ⇒ Bring copies of school records for each dependent enrolled in school, to include Special Education Records (IEPs, 504 plans, etc.)
- \Rightarrow Bring copies of medical records for yourself and dependents.
- \Rightarrow Bring medication/medical supplies to meet your Family's needs for 90 days.
- ⇒ Obtain any medical documentation prior to leaving that can assist you with housing accommodations at your next duty location.

Complete DA Form 7415 and Family Needs Assessment indicating that you will be PCSing and return completed forms to ACS EFMP. Your information will be forwarded to the gaining installation. The gaining installation will assess your needs and coordinate services for your Family including linkage to the School Liaison and local Medical Treatment Facility.
